Our Privacy Notice is designed to help you understand how we collect, use, and share your personal information and to assist you in exercising the privacy rights available to you.

SCOPE OF THIS NOTICE

This Privacy Notice applies to personal information processed by us in our business, including on the Collaborative Rating Systems LLC Platform and through related online and offline offerings. To make this Privacy Notice easier to read, the Collaborative Rating Systems LLC Platform and our related offerings are collectively called the "Services."

Capitalized terms used in this Privacy Notice and not otherwise defined herein shall have the meanings provided in the Collaborative Rating Systems LLC Terms of Service.

AN IMPORTANT NOTE

This Privacy Notice does not govern Collaborative Rating Systems LLC's processing of personal information within User Data. Our Customers are responsible for providing the appropriate notice to and obtaining any required authorizations from individuals for the processing of User Data. Our customers' respective privacy policies govern the collection and use of User Data. Collaborative Rating Systems LLC is a "processor," "service provider," or other similar term of User Data and its processing of User Data is governed by the Terms of Service or the Customer Agreement it has with its Customer.

PERSONAL INFORMATION WE COLLECT

The categories of personal information we collect depend on how you interact with our Services.

INFORMATION YOU PROVIDE TO US:

- Account Information:> When you create a Collaborative Rating Systems LLC account, we may collect personal information from you such as your name, username, address, email address, telephone number, image, billing and payment information, and other information.
- **Customer Service and Support:**> If you call or otherwise interact with Collaborative Rating Systems LLC's customer service and support, we may collect the information you provide to our representatives.

- Conferences, Trade Shows, and Other Events:> We may attend conferences, trade shows, and other events where we collect personal information from individuals who interact with or express an interest in Collaborative Rating Systems LLC and/or the Services. If you provide us with any information at one of these events, we will use it for the purposes for which it was collected.
- **Business Development and Strategic Partnerships:**> We may collect personal information from individuals and third parties to assess and pursue potential business opportunities.
- **Job Applications.** We may post job openings and opportunities on the Services. INFORMATION COLLECTED AUTOMATICALLY:

- **Pixel Tags/Web Beacons.** A pixel tag (also known as a web beacon) is a piece of code embedded on the Services that collects information about users' engagement on the Services. We may also include web beacons in e-mails to understand whether messages have been opened, acted on, or forwarded.

De-identified and/or aggregated information is not personal information, and Collaborative Rating Systems LLC may use such information in a number of ways, including research, internal analysis, analytics, and any other legally permissible purposes.

Sharing Content with Friends or Colleagues: Collaborative Rating Systems LLC's Services may offer functionality to forward or share information, alerts, or content to others.
